Brickwork Ratings reaffirms the Ratings for the Bank Loan facilities of ₹ 16.20 Crores of AAP Infrastructure Ltd (AAP or ‘The Company’) and maintains the rating in the ‘Issuer not cooperating’ category based on best available information, as the issuer did not cooperate.

RATING ACTION / OUTLOOK / NATURE OF NON-COOPERATION

Long term rating reaffirmed at BWR D (Issuer not Cooperating) on best available information as the issuer did not cooperate.

The rating was due for a review in March 2020. BWR took up with the issuer to provide required information over emails and through telephone calls. Despite the best efforts of BWR to get the minimum required information for a review, the entity has not provided the same. In the absence of adequate information from the Company, BWR is unable to assess the Company’s financial performance and its ability to service its debt and maintain a valid rating. Lender has also reported irregularities in the conduct of rated bank loan accounts.

LIMITATIONS OF THE RATING: Information availability risk is a key factor in the assessment of credit risk as generally, noncooperation by the rated entities to provide required information for a review of the assigned rating may also be accompanied by financial stress. Users of the credit ratings should therefore take into account the possible deterioration in the credit quality of the rated entity arising from its non-transparency and withholding of information required for a review of the rating.



COMPANY PROFILE

AAP Infrastructure Limited (AAP Infra) was incorporated in Dec 2002 based in Kolkata, West Bengal. The Company is a 100% subsidiary of MBL Infrastructures Ltd. AAP Infra was formed as a Special Purpose Vehicle (SPV) to undertake the build-operate-transfer (BOT) project with the Madhya Pradesh Road Development Corporation Limited on the Seoni – Balaghat - Gondia road in MP.
