Ratings: Revised to ‘D’ and Withdrawn

The mandate was last rated on 09-Dec-2015 and due for review in Dec’16. However, despite close follow-up, the Company did not provide any information to complete the review process. In the absence of receipt of required information for review, it was transferred to “Rating not Reviewed” Category in Mar’17.

Continued follow-up has not resulted in any information flow and as such, review has not been possible. Considering the lack of developments and based on publicly available information, BWR has revised the rating as mentioned above and withdrawn the same as per the withdrawal policy of BWR. As the revised rating is not based on up to date data, the rating may not reflect the present position of the Company, as information availability risk is a key factor in the assessment of credit risk.

Adhunik Power and Natural Resources Limited (Erstwhile Adhunik Thermal Energy Ltd) was incorporated in 2005 with the objective of generating,distributing and transmitting power.The registered office and corporate office locate in Kolkata.
