RATING ACTION / OUTLOOK / NATURE OF NON-COOPERATION

Reaffirms the long term rating at BWR D (Issuer not cooperating) based on best available information as the Issuer did not cooperate.

The initial rating was done on 28th Sept, 2016 with the rating as BWR B (Stable). Then the rating became due for review on 28th Sept, 2017. Subsequently on 21st May, 2018 the long term rating was downgraded at BWR C under the Issuer Not Cooperating category. Later on 02nd March, 2020, rating was further downgraded at BWR D under Issuer Not Cooperating. BWR took up with the issuer/ bank to provide required information over emails. Despite the best efforts of BWR to get the minimum required information for a review, the entity has not provided the same and no feedback was received from the Bank. The entity has also not provided the NDS. In the absence of adequate information from the firm, BWR is unable to assess the firm’s financial performance and its ability to service its debt and maintain a valid rating.

LIMITATIONS OF THE RATING

Information availability risk is a key factor in the assessment of credit risk as generally, non cooperation by the rated entities to provide required information for a review of the assigned rating may also be accompanied by financial stress.
