RATING ACTION / OUTLOOK / NATURE OF NON-COOPERATION

In view of non- availability of information and lack of cooperation from the company, Brickwork Ratings has downgraded the long term rating as “BWR D” under “Issuer Not Cooperating” for the bank loan facilities amounting Rs. 8.62 Crs for Ashritha Healthcare Pvt. Ltd..

The lenders/investors June note to exercise due caution while using the above ratings which mentions "**Issuer Not Cooperating**" since the ratings lack any projections or forward looking component as it is arrived based on the best available information without any management/banker's interaction.

The rating was due for a review in Nov, 2019. BWR took up with the firm to provide required information over emails and through telephone calls. Despite the best efforts of BWR to get at least the minimum required information for a review, the entity has not provided the same. In the absence of adequate information from the issuer, BWR is unable to assess the firm's financial performance and its ability to service its debt and maintain a valid rating.

LIMITATIONS OF THE RATING

Information availability risk is a key factor in the assessment of credit risk as generally, non-cooperation by the rated entities to provide required information for a review of the assigned rating June also be accompanied by financial stress. Users of the credit rating should therefore take into account possible deterioration in the credit quality of the rated entity arising from its non-transparency withholding of information required for a review of the rating.

The company has not submitted the financial information to BWR from the last three years for review.

Ashritha Health Care Services Private Limited was incorporated as a Private Limited company on 24th August,2012. The Company is promoted by its Directors Dr. Bhargavi Reddy (MBBS,MD) and Dr. Shekhar Reddy(BDS). The promoters currently run a 25 bedded hospital on a rented premise in Thippasandra, Bangalore named “Dr Bhargavi Reddy Women and Child Care Hospital”. The hospital provides treatment in various department viz. gynecology, pediatrics, general physician, general surgeon, dermatology, cosmetic, internal medicine, GI surgery etc.
