

**LIST OF OUTSTANDING CE (CREDIT ENHANCEMENT) RATINGS
IN LINE WITH SEBI CIRCULAR GUIDELINES OF 13 JUNE 2019 &
SUBSEQUENT CLARIFICATIONS**

In compliance with the revised instructions received from the Securities Exchange Board of India [SEBI] vide their circular No. SEBI/ HO/ MIRSD/ DOS3/ CIR/ P/ 2019/ 70 dated 13.06.2019, Credit Rating Agencies need to suffix ‘CE’ for instruments with external credit enhancement, which, hitherto used to be ‘SO’.

As per the above circular followed by further clarifications, the suffix will be governed by the following broad principles:

- ❖ In order to have suffix as “CE” the instrument should have explicit credit enhancement from a third party as Corporate Guarantee / Letter of Comfort / Pledge of Shares, etc.
- ❖ Other ratings where the suffix will continue to be “SO” derive credit enhancement by means of asset backed securitization, mortgage backed securitization and collateralized debt obligations.
- ❖ Capital Protection Oriented Funds will continue to have suffix as “SO”.

Suffix will be added only to the ratings as detailed above and no other ratings will have any suffix.

Based on the above guidelines, BWR has replaced “SO” suffix with “CE” for those instruments / facilities which qualify for the change as per the appended list.

The modifications in the suffix is only due to the revised instructions and it should not be construed to be a revision in the ratings. This modification does not change BWR’s opinion on the instrument / facility.

Unsupported Ratings / Standalone Ratings will be assigned to each instrument / facility at the time of review of the rating.
